Mayor Pro Tem Joaquin Zamora called the meeting to order.

1. DISCUSSION OF FY 2021-2022 CITY OF MCALLEN BUDGET WRAP-UP.

Management briefly spoke about the budget wrap-up fiscal year 2021-2022. Council heard presentations on the General Fund, PEG Fund, American Rescue Plan Fund, Infrastructure & Improvement Fund, Development Corporation Fund, Capital Improvement Projects Fund, Palmview Golf Course Fund and Airport Fund, PFC and CIP Funds.

A discussion ensued. Comments and concerns were shared by Council. Questions were asked regarding MOU & MISD, PEG Fund restrictions, Copa Amistad /Soccer, Taylor Road 2 Mile to 4 Mile, Boarding Bridges, Airport VIP Lounge and Heritage Center. Questions posed by Council were answered.

Staff noted that recommendations and changes would be discussed at the September 27th Regular City Commission for adoption.

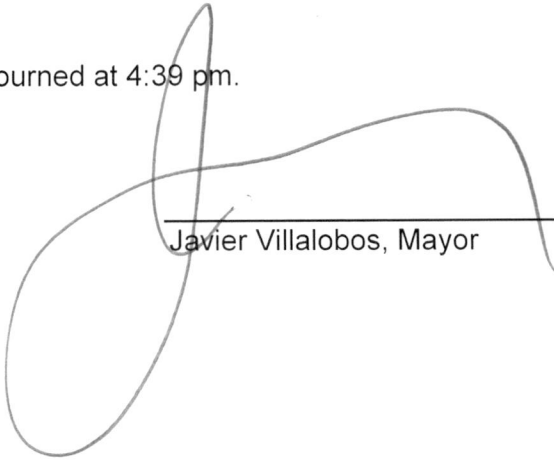
