Mayor Pro Tem Omar Quintanilla reconvened the meeting at 4:55 pm and announced action would be taken at the regular meeting.

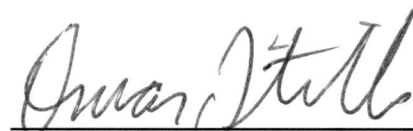
