CALL TO ORDER

Mayor Pro Tem Omar Quintanilla called a special meeting to order.

A) OFFICIAL CANVASS OF CHARTER AMENDMENT ELECTION RETURN FOR THE CITY'S SPECIAL ELECTION HELD NOVEMBER 5, 2024. (CONVOCACION OFICIAL DE LOS RESULTADOS DE LA ELECCION ESPECIAL DE LA CIUDAD DE MCALLEN QUE SE LLEVO ACABO EL 5 DE NOVIEMBRE 2024).

Mayor Pro Tem Omar Quintanilla read the total votes cast for each proposition as follows:

Proposition A – For 22,924
 Against 17,774

Proposition B – For 26,967
 Against 13,328

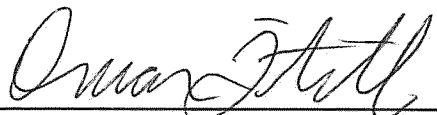
B) ADOPTION OF AN ORDINANCE CERTIFYING THE RESULTS OF CITY OF MCALLEN SPECIAL CHARTER AMENDMENT ELECTION HELD NOVEMBER 5, 2024. (ADOPCION DE ORDENANZA CERTIFICANDO LOS RESULTADOS DE LA ELECCION ESPECIAL DE LA CIUDAD DE MCALLEN QUE SE LLEVO ACABO EL 5 DE NOVIEMBRE 2024).

Mayor Pro Tem Omar Quintanilla recommended adoption of an ordinance certifying the official special election results for the Special City Election as the City Commission officially finds, determines, and declares the result of said election to be that propositions so submitted received a favorable majority votes at the Special Charter Election held November 5, 2024, as canvassed and seconded by Commissioner Joaquin Zamora. The motion carried unanimously.

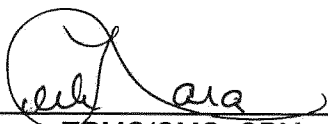
