**CALL TO ORDER**

Mayor Jim Darling called the meeting to order.

Questions were raised as to: 1) Police Officers and parks named after them, 2) City workers killed in the 1960's, 3) bringing recommendations at another future meeting, 4) list of recommendations from Mr. Guerra and 5) researching names of the 3 or 4 employees who worked in the sewer repair situation. Staff answered questions posed by the Mayor and City Commission.

The City Commission directed staff to bring back recommendations for another future meeting.

Mayor Jim Darling thanked staff for their presentation.

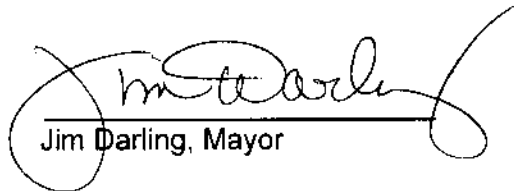

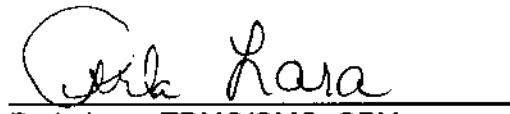
